NED - The Dutch Hansa Class would like to bring in following proposal to include the following points in the future evaluation criteria for expressions of interest for Hansa Class World and International championships.

#### Please add:

Sufficient area to allow competitors to enter their boats while on land and with a launch facility nearby and a C-crane on a jetty to get the keel in.

Please add addition to 2.15 Supply of nearby accessible accommodation: Please make sure there are at least (number to be debated) 15 accessible accommodations with roll in shower options for shower wheelchair use, at reasonably payable hotels (<4 stars) and make a list available at the moment of filing the expression of interest.

Zoltan Pegan: With respect to item 10 and the proposal from NED regarding changes to the criteria listed in the Expressions of Interest, I believe that the more specific we (IHCA) can be in what we (the sailors) require and expect at host venues, the better. I will confer with the Dutch sailors on this, and we will take steps to update and improve the Race Management Manual.
