

Application for Approval of Replacement or Additional Equipment (July 2024)

Important Notes

- a) All applications must be forwarded as a Word document with photographs and supporting documentation provided as separate files (JPG images preferred).
- b) All applications approved, are only for the hull or hulls noted in the application unless otherwise specified by the Technical Committee.
- c) Applications can be updated upon request in writing if the equipment is transferred into a different hull.
- d) Applications should made *no less than 28 days* before the equipment is to be used in competition.
- e) Applications will be processed and advice provided to the applicant within 14 days of the Technical Committee Secretary receiving the application via email at info@hansaclass.org
- f) Equipment may not be used in competition until 14 days after approval has been advised.
- g) Applications for items that **are** permitted by the class rules will not be accepted.
- Applications must include all appropriate dimensions along with detailed plans or photographs, along with a reason for requesting the modification / equipment.
 Applications will be declined where insufficient information is provided.

Application Types

There are three types of application that can be made using the attached form:

- **1. Crew Equipment Application** Additional equipment that provides for a sailor's limited strength, movement or dexterity (i.e. hand grips, straps, foot straps etc). Applications require the written approval of the Class Technical Committee 14 days (2 weeks) before use in competition.
- **2. Equipment Repair Application** Modification and repair of hulls, foils & spars that in any way affects structural integrity, weight distribution, stiffness, friction or the location of control points. Applications require the written approval of the Class Technical Committee 14 days (2 weeks) before use in competition.
- **3. New Equipment Application** Proposals for new equipment that would benefit the class. Applications that have the support of the SKUD 18 Committee will be included in the quadrennial review of SKUD 18 Class Rules, any amendments to which require the approval of the IHCA Technical Committee and World Sailing.

Application Approvals

Applications shall be approved either for:

- An individual. The approval applies only to the applicant. Sailors wishing for similar modification will need to make a separate application with supporting evidence of the need.
- 2. **General**: An RAE approved for general use may apply to all boats and sailors without further action.
